1986 NACS CONFERENCE

The next NACS conference will be held at the University of Texas at El Paso from Thursday, April 10, through Saturday, April 12, 1986. The theme of the conference is "Decisiones para el futuro en tiempos criticos." More than 80 panels are planned, covering a diversity of subjects of concern and interest to Chicano scholars that include topical matters such as immigration, economics, science, and research. The full range of topics is listed in the call for papers that is reprinted in this newsletter. In addition, a plenary session at la Universidad Autonoma de Juarez is anticipated. There will be several social and cultural activities as well.

It is noteworthy that this conference is being held on the border. In addition to the general historical interest of the area, there are many fascinating things to see and do, both for conferees and family members of all ages. El Paso and its sister city Ciudad Juarez are growing rapidly, their respective populations being approximately 500,000 and 1,000,000. The location, known as the high desert, has one, sometimes two snowfalls a year. At the time of the conference, however, light clothing should be appropriate. It is normally sunny and warm in the daytime and cool at night.

A list of the hotels and motor lodges in El Paso and Ciudad Juarez that are offering special conference rates will be forwarded with the conference packets to all NACS members. Additionally, limited dormitory accommodations will be available on the U.T. El Paso campus.

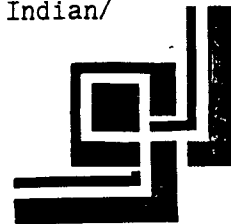
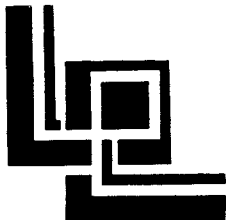
RESOLUTION

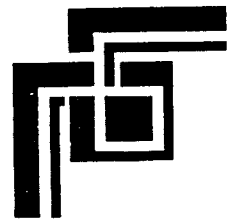
The Following Resolution was passed at the 1985 NACS Conference in Sacramento.

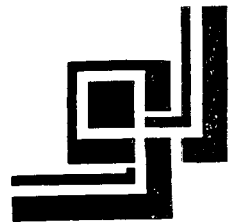
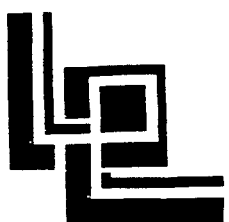


TEXAS FOCO

1. A conference entitled "Mexicans at Work" will be sponsored by the Mexican American Studies Program at the University of Houston-University Park Campus on November 14, 1985. Guest speaker will be Emma Tenayuca. Papers will be presented by Lea Ybarra, Rosario Torres Rains, Marta Lopez Garza, Rosalia Solorzano Torres, Alicia Chavira, Julia Curry, and Patricia Fernandez Kelly. Reading from their works at a reception in honor of the conference participants will be Angela de Hoyos, Sandra Cisneros, and Evangelina Vigil Pinon.

2. The Mexican American Studies Program of the University of Houston-University Park Campus announces its Visting Scholars Program. The Program, made possible through a special appropriation from the Texas legislature, is designed to bring promising junior and distinguished senior scholars to the University Park campus for the purpose of undertaking research relevant to the Mexican American community. The first visiting scholar will be Dr. Arnoldo De Leon, Associate Director of History at Angelo State University, who is considered the leading historian on Mexican Americans in Texas. Professor Leon is best known for his books The Tejano Community, 1836-1900 (University of Texas Press, Austin 1982) and They Called Them Greasers: Anglo Attitudes Towards Mexicans in Texas, 1821-1900 (University of New Mexico Press, Albuquerque 1983). Dr. De Leon will be in residence from January to August 1986. During his residency he will write the history of Mexican Americans in Houston which will be published as part of the Mexican American Studies monograph series.

3. The Center for Mexican American Studies at the University of Texas in Austin is sponsoring a symposium entitled "Ignored Voices: Public Opinion Polls and the Latino Community" on Friday, October 18, 1985. Participants include Congressman Robert Garcia of New York and Representative Albert Luna, chairman of the Texas Mexican American Legislative Caucus; editors from the Los Angeles Times and the Washington Post; directors of the CBS/New York Times and Los Angeles Times polls; and representatives of major national polls such as the Southwest Voter Registration Education Project, Gallup, Lance Terrance Associates, and Yankelovich, Skelly, and White, Inc. Participating scholars include Benjamin Page, James Prothro, F. Chris Garcia, and Bruce Cain.
