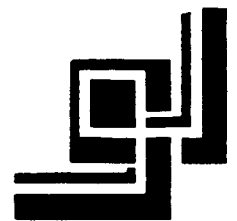
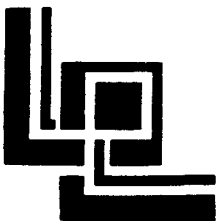
Each regional representative is responsible for disseminating this information to its focus members well in advance of the national conference". Note, it is NOT necessary that these resolutions be passed by the regional focus prior to their presentation to the general body although this may strengthen their chances of being approved. The purpose of this new policy is to allow discussions of resolutions in the focus meetings at the national conference PRIOR to the business meeting.


## NOMINATIONS FOR THE HONORING OF AN INFLUENTIAL SCHOLAR IN CHICANO STUDIES

Recognition of the significant contributions of a scholar to Chicano Studies may be included in the affairs of the National Association for Chicano Studies at its national conference upon the recommendation of the NACS Coordinating Committee and Site Conference Coordinator.

The general criteria for such recognition should include:

1. a scholar's personal history of involvement in the development of Chicano Studies literature or as a discipline; and

2. his/her significant contributions to scholarly research and writing on the Mexican population in the United States.

Nominations for such an award should come from individual Focos and/or the Site Committee. Such nominations should include an explanation of the appropriateness of such an award at a specific conference.

It is recommended that in order to insure the special quality of the award, that nominations be submitted only in behalf of those scholars whom the majority of the NACS membership would readily recognize and heartily endorse. Moreover, the frequency of this award should be carefully weighted by the NACS Coordinating Committee. This is not necessarily meant to be an annual award.

The mechanics of carrying out this endeavor should be by the mutual consent of the NACS Coordinating Committee and the Site Committee.

#### CURRICULAR RESOURCES IN CHICANO STUDIES

The Center for the Study of United States Hispanics (State University of New York at Binghamton), the National Association for Chicano Studies, and the National Chicano Council on Higher Education have received a grant from the Ford Foundation to produce undergraduate and graduate curricular resources in Chicano Studies. At the





undergraduate level the project is authorized to produce syllabi for two or three courses important to Chicano Studies in the following areas:

1. Interdisciplinary, introductory level courses in Chicano/Chicana studies
2. history
3. literature and the arts
4. sociology
5. anthropology and folklore
6. psychology
7. political science
8. economics

Additionally, although we do not have authorization to prepare syllabi in the area of education, we are seeking approval for this field as well.

The Project is asking that all faculty members interested in the eight areas described above as well as education submit to us the current syllabi that they are using which they feel might be of general use in the field of Chicano Studies. A joint committee of the project is expected to review all of the syllabi submitted to us and select from this group a number which we will like to include in a book publication for wide distribution (after appropriate revision in accordance with guidelines to apply for all of the syllabi that are currently under preparation). The Project will be able to pay a modest honorarium for all syllabi which are identified by this process for publication (after revision in accordance with the guidelines). The Project is interested not only in the coverage of the disciplines described above but also in the incorporation of syllabi geared at different levels of college and university settings. 
#### EDITORIAL BOARD CANDIDATES

Ignacio Garcia: Publications coordinator at the Mexican American Studies & Research Center at the University of Arizona in Tucson. Editor of the Renato Rosaldo Lecture Series Monograph, and managing editor of the Saguaro literary journal. Also

directs special books projects for the Center. Next book project is Miguel Mendez's newest book of short stories on the border. Currently doing graduate work in ethnohistory and public history.

Julian Olivares from San Antonio, Texas, received the Ph.D. in Spanish Literature from The University of Texas, Austin, and is an Associate Professor (1986-) of Spanish and Mexican American Studies at the University of Houston, where he is also Co-Editor of Revista Chicano-Riquena and Associate Editor of Arte Publico Press. In addition to his The Love Poetry of Francisco de Quevedo (Cambridge, 1983), he is the author of numerous articles and papers on Chicano writers, including an article on Evangelina Vigil selected from the proceedings of the 1983 NACS Conference, and published in The Chicano Struggle. He is a contributor and editor of International Studies in Honor of Tomas Rivera (at press), and editor of books by Ana Castillo (Women Are Not Roses), Pat Mora (Chants), Tino Villanueva (Shaking Off The Dark), Denise Chavez (The Last of the Menu Girls, at press), and Gary Soto (Small Faces, at press). His editorial duties with Revista Chicano-Riquena and Arte Publico Press make him eminently qualified for the Editorial Board. His awards include: Ford Foundation Dissertation Fellowship for Minorities (1974-76), American Council of Learned Societies Grant-In-Aid (1979), National Endowment for the Humanities Summer Institute in Spanish Paleography, Newberry Library (1984), and National Research Council/Ford Foundation Senior Fellowship for Minorities (1985-86). He is a member of the Coordinating Council of Literary Magazines.

Mary Romero: is currently an Assistant Dean at Yale College. She has been a Visiting Assistant Professor in Chicano Studies at University of Colorado and Assistant Profes-



sor in Sociology at the University of Wisconsin-Parkside. Previously she was a lecturer in Sociology at the University of Texas at El Paso and Regis College in Denver. Dr. Romero has published numerous articles relating to the past and present conditions of Chicano communities in the Southwest. Her research includes chicana domestic workers, land issues in New Mexico and Texas, bilingualism, and the impact of public policy and social services on Chicano communities. In 1985, Mary Romero edited Syllabi and Instructional Materials for Chicano Courses in Sociology a teaching resource published by the American Sociological Association. For the last two years she has edited the NACS newsletter. At Yale, she is editing the Hector P. Garcia Lecture Series Monograph and Cambios. She has published chapters in books and articles in journals including: Sex Roles, Campo Libre, Women's Studies, Revista Mujeres and the American Sociological Association journal Research in Social Policy: Critical Historical and Contemporary Perspectives.

Juan Rodriguez: Tenured Assistant Professor of English and Spanish, Director of Mexican American Studies at Texas Lutheran College. Editor of: Carta Abierta (1975- ), Relampago Books Press (1980- ); owner of Relampago Books, a Chicano books distributor; compiler of Las Cronicas Diabolicas de Jorge Ulica; and author of more than 50 articles on the Chicano experience.

Vicki L. Ruiz: I am a third generation Chicana who received a doctorate in History at Stanford University in 1982. My area of research concerns the historical experiences of Mexican women in the United States with a particular focus on labor activism among twentieth century Chicana workers. For three years I was an assistant professor in History at the University of Texas, El Paso

(UTEP). From August 1983 to May 1985, I was director of UTEP's Institute For Oral History and a member of the Editorial Board of Texas Western Press. In 1984 I was chair of the annual Sonnechisen Prize Committee for the best book-length manuscript submitted to Texas Western Press. I have also reviewed articles for several academic journals. Currently I hold the rank of assistant professor in History at the University of California, Davis. Besides NACS, I am member of the Organization of American Historians, the Western Association for Women Historians, and Mujeres Activas En Letras Y Cambio Social.


